1. Introduction

This policy shows how Conquest School intends, over time, to increase accessibility to the physical environment, the curriculum and written information so that all students/students with a disability can take full advantage of their education and associated opportunities.

2. Aims

To increase and eventually ensure students/students with a disability have:

- total access to our setting’s environment, curriculum, and information and
- full participation in the school community.

3. Principles

Compliance with the Equality Act is consistent with our setting’s aims and equality policy.

- Our staff recognise their duty under the Equality Act:
 - Not to discriminate against disabled students in their admissions and exclusions, and provision of education and associated services.
 - Not to treat disabled students less favourably.
 - To take reasonable steps to avoid putting disabled students at a substantial disadvantage.
 - To publish an accessibility plan.
 - In performing their duties governors have regard to the Equality Act 2010



The school recognises and values the young person's knowledge/parents' knowledge of their child's disability and recognises the effect their disability has on his/her ability to carry out activities and respects the parents' and child's right to confidentiality.

Conquest School provides all students with a broad and balanced curriculum that is differentiated, personalised and age appropriate.

4. Increasing Access

This includes teaching and learning and the wider curriculum of the school such as participation in after school activities, leisure and cultural activities or school visits.

5. Improving Access

This includes improvements to the physical environment of the school and physical aids to access education.

6. Improving Delivery

Ensuring that written information that is normally provided by the school to its students is available and accessible to disabled students. Examples might include handouts, timetables, textbooks, and information about school events.

Improving access to information and written material through provision of assistive technology, accessible signage, and publications

The information should take account of students' disabilities and students' and parents preferred formats and be made available within a reasonable time.

7. Financial Planning and Control

The headteacher, SLT and the finance committee will review the financial implications of the accessibility plan as part of the normal budget review process.

8. Approval

This policy will be reviewed as a minimum annually by the headteacher. At every review, the policy will be approved by the chair of governors.
